



The Movement of Hidden Forces

Spiritually speaking, most of us have realized that the physical world is the result of hidden or unseen forces. Saint Paul of the New Testament makes this abundantly clear when he states, “By faith we understand that the worlds were prepared by the word of God, so that what is seen was not made out of things which are visible.”¹ Basically, Saint Paul is saying that the physical world is just the effect of the invisible world.

There are of course many worlds both visible and invisible to our natural physical senses. Ancient seers sought the meaning to worldly events both current and future through many methods commonly known as divination. Many modern day astrologers, tarot readers, psychics, and crystal ball gazers are but a pale reflection of these traditions which seek to divine the forces that shape our world in every category, even politically.

Today there are several types of individuals who have knowledge of the invisible forces shaping our world and culture:²

- (1) There are *occultist/initiates* who have higher knowledge about the secret histories of humanity and the hidden purposes of the Divine Plan. They may or may not belong to a secret brotherhood, many of them do. They do not necessarily have occult powers or clairvoyance.
- (2) There are *psychics* who have clairvoyance, but they do not have

the initiatory knowledge to know what they are actually seeing. Many of them use astrology or some form of divination to give them a mental cohesion.

- (3) There are *practical-occultists* who have the ability to do phenomena. We sometimes call them magicians. There are white magicians who are healers and serve others. There are black magicians who only serve themselves.
- (4) Finally, there are Adepts-Masters who have occult knowledge, clairvoyance, and the power to perform magic at will.

Based on the premises given thus far, we can safely assume that there are occult brotherhoods within and behind every nation today making policy and influencing humanities development either with the Divine Plan or against it.

The Hidden Hands

Each and every great occultist such as Helena Petrovna Blavatsky, Rudolf Steiner, and many others have all testified to the existence of secret brotherhoods.³ The brotherhoods tend to be the guardians of their own particular culture. From behind the scenes they usually and successfully influence the direction of a nation.

The brotherhoods are not one big happy family of identical ideologies or purposes. Generally they fall into several groups.

- (1) *Liberal Esotericist* believe that humanity is ready for more occult knowledge such as how we can use ether instead of fossil fuels to fulfill our energy needs. The etheric field is sometimes known as the Zero-Point field by modern day physicists.
- (2) *Conservative Esotericists* are of the opinion that humanity cannot be trusted with the secrets that govern disease, life, and death. They feel we are too primitive to be trusted with such truths.
- (3) *Brothers of the Left* are occultist with political agendas of their own. They take advantage of the knowledge they have of the Divine Plan and use it to steer humanities destiny in the direction they would like to see it go. Steiner credits them with starting World War I and orchestrating all that was needed to pull it off.⁴
- (4) *Black Magicians* are too egocentric to organize as a brotherhood or organization capable of any long term coherency (thank God for that).

Methods Used by the Brothers of the Left

Sevak Edward Gulbekian in his book, *In the Belly of the Beast*, shows several methods by which secret brotherhoods can and do operate.⁵ By knowing the intimate details of the Divine Plan, the Brothers of the Left are able to delay or thwart the plans of the Divine.

For example, if they know a great soul is to be born that will greatly influence the direction of humanity against their own selfish political ends; they may affect that soul's development in a variety of ways.

Both Rudolf Steiner and Gulbekian mention the tragic story of Kaspar Hauser.⁶ Kaspar

Hauser was a highly developed soul whose influence on Middle Europe would have prevented World War I. The Brothers of the Left knew that if they murdered him, spiritual law would allow him to reincarnate very soon and the problem would start all over again. Therefore it was decided to kidnap him at birth and tell his parents that their child was born dead. He was replaced with the body of a child that had been born dead.

Hauser was raised in captivity for fifteen years and then released upon the streets of Nuremberg, Germany. When authorities found him, he could not speak having never been taught how. After his long recovery it was discovered that he had been raised in a cage, in darkness, for fifteen years. Several attempts were made upon his life because he began to recover to his true spiritual potential and was finally stabbed to death by an assassin. In this tragedy, the Brothers of the Left were successful, World War I happened as they wanted it too. The thinking and methods behind this event by the Brothers of the Left are summed up by Gulbekian as follows:⁷

- (1) The child was not killed at birth because it was known that such a soul could quickly reincarnate.
- (2) The child was imprisoned by the age of three to prevent and hinder individual consciousness and further development.
- (3) By imprisoning the child the soul was captured between birth and death.
- (4) He was released at the age of fifteen because it was believed that his power and influence had been nullified.
- (5) When it was realized the in spite of his great handicaps that he would recover, he was killed.

Researchers believe and have much evidence to support that Kaspar Hauser was a descendent of the Zharingen Dynasty and was destined to be the next Grand Duke of Baden.⁸ All this was orchestrated and accomplished by the Brothers of the Left for their political ends. What these ends are entail more than just World War I. Many times, whole epochs are manipulated such as the one perpetrated upon the whole Slavic Race.

Manipulation of the Sixth Sub-Root Race

All occultists know that at certain times in history a group of people will dominate for an epoch. We call it history. The purpose of this dominance is to bring to all of humanity new abilities and insights. It is taught that there are Seven Sub-Root Races in our current epoch. Occultist Rudolf Steiner teaches that we are in our 5th Sub-Root Race and it is known as the European.⁹ Obviously, European dominance is felt already everywhere to day in world. Stretching its cultural influence everywhere including the communist manifestoes in China and North Korea, to its socialist influences through Europe and Canada, to its Capitalistic influences in the West. All of these original concepts and economical philosophies are from European authors.

Everyone wears blue jeans and uses a cell phone, even Islamic terrorist. There are now so many satellites in the skies above our atmosphere that there is a greater danger of collision and space debris then ever before.

The Brothers of the Left also know that the Slavic people will eventually become the dominant people of the 6th Sub Root Race. Their gift will be experiments done in socialism that will bring about a compassionate economical system superior

to capitalism. The Brothers of the Left who thrive on a vicious form of materialistic capitalism want no part of this. As Gulbekian points out in his book, the Brothers of the Left had a plan to avert this development also.

Their plan or strategy was to introduce communism sooner than was planned so that the Slavic or Russians would fail. This is why conspiracy theorists always find a money trail leading back to the Western financing that was behind both Adolph Hitler and the over through of the Czar of Russia. The Brothers of the Left now believe that with the fall of the USSR that they have been successful. Unfortunately, it cost over seventy million human lives to pull it off.

A Biblical example of *ideal* communism that is often over looked takes place in the Book of Acts. The early Christian church as recorded in the Book of Acts, Chapter 5, practiced a *voluntary* communism. Everyone who wanted to participate sold all that they had and gave it to the Church to distribute as needed. Ananias and his wife Sapphira sold a plot of land they had and came to the apostle Peter to give him the money. However they held back some of the money and lied about it. Thus, they were both in turn struck dead by the Holy Spirit for lying to God.

There are many meanings to this story on multiple levels. However, for our purposes it clearly shows that humanity is not ready to live in the idealistic communism of the Bible or the worse one proposed by the former Soviet Union. We are too primitive to let go of our possessions for now and that is not wrong for the time in which we live.

The Brothers of the Left have succeeded in only forestalling the inevitable rise of the

Slavic people and their ability to someday create a compassionate system of economics. Until then we can see the rhetoric being perpetrated and the manipulations of the public by the mainstream media. They have been effective to the point of actually instilling a mindless irrational fear in the public at the very mention of the word *socialism*.

Currently we suffer under a media created class war started by the Brothers of the Left who want to polarize the classes in America. Divide and conquer is a tried and true method. The vast majority of the people involved in this mass manipulation have not a clue that they are under a form of mind control. Some Conclusions

Our best defense against such “organized” evil is to be aware of their agendas, and to build communities of awareness together. America’s socialist development over the last 100 years, as well as its capitalistic development, is both right and proper for the time in which we live.

We cannot go back in time to a primitive capitalism built on the backs of slaves as in before the industrial revolution. Limited to the agrarian age in which they lived, the writers of the constitution allowed for amendments as needed for the very reason that life is in motion. Life is not static and things change. Thomas Jefferson knew that with the industrial revolution, the country would be radically changed. The independence of the yeoman farmer who grew his own food, made his own clothes, and pulled himself up by his own boot straps

would end (and with it slavery). Industrialization made the masses wage dependent and no longer land independent. To keep the disparity between classes from widening to a point of apathy, Aristotle encouraged a strong middle class in his political theory. Aristotle wanted a middle class who had a stake in the culture through property ownership and reasonable prosperity.

Finally, when you see four men beating on a woman in public at a political rally, and no one is coming to her rescue in a crowded area, realize that the mind control is working.¹⁰ And for those of you who think you are immune to the Brothers of the Left and their antics, they already have you where they want you.
